**DECISION OF THE EEA JOINT COMMITTEE**  
**amending Protocol 31 to the EEA Agreement,**  
**on cooperation in specific fields outside the four freedoms**

## EXPLANATORY MEMORANDUM

1. Protocol 31 to the EEA Agreement contains specific provisions on the cooperation between the Community and the EEA EFTA States outside the four freedoms.
2. The attached draft Decision of the EEA Joint Committee aims to modify Protocol 31 to extend cooperation, beyond 31 December 2004, in the field of the implementation and development of the internal market for a further year (2005) and concerning:
  - **Budget lines 12.01.04.01 and 12.02.01:** Implementation of the internal market.
3. Article 1.3(b) of Council Regulation (EC) No 2894/94 concerning the arrangements for implementing the EEA Agreement envisages that the Council establish the Community position for such Decisions on a proposal from the Commission.
4. The draft decision of the EEA Joint Committee is submitted for the approval of the Council, after which the Commission will put forward the position of the Community in the EEA Joint Committee at the earliest possible occasion.

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as ‘the Agreement’, and in particular Articles 86 and 98 thereof,

Whereas:

- (1) Protocol 31 to the Agreement was amended by Decision of the EEA Joint Committee No .../... of ...<sup>1</sup>.
- (2) It is appropriate to continue the cooperation of the Contracting Parties to the Agreement to include cooperation in the implementation and development of the Internal Market.
- (3) Protocol 31 to the Agreement should therefore be amended in order to allow for this cooperation to continue beyond 31 December 2004,

HAS DECIDED AS FOLLOWS:

*Article 1*

In Article 7(6) of Protocol 31 to the Agreement the words ‘year 2004’ shall be replaced by ‘years 2004 and 2005’.

*Article 2*

This Decision shall enter into force on the day following the last notification to the EEA Joint Committee under Article 103(1) of the Agreement\*.

It shall apply from 1 January 2005.
