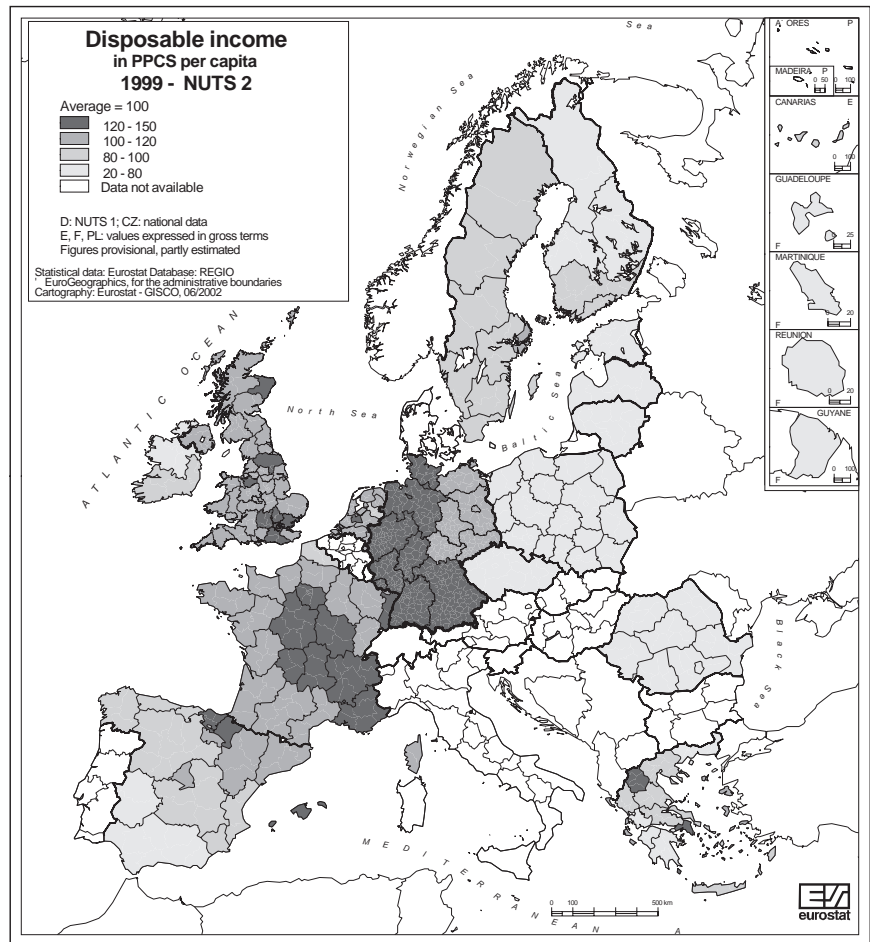

The main purpose of this document is to look at the relationship between the disposable income of households and the Gross Domestic Product (GDP) at regional level. The regions having the highest GDP per capita are not necessarily the ones having the highest disposable income. The difference can be partly explained by the commuting flow of workers and the redistribution by governmental bodies. In comparison to the lowest 30 regions by GDP, there are fewer Greek (and no German or British) regions in the lowest 30 by disposable income alone; by contrast, there are more Finnish and Swedish regions.

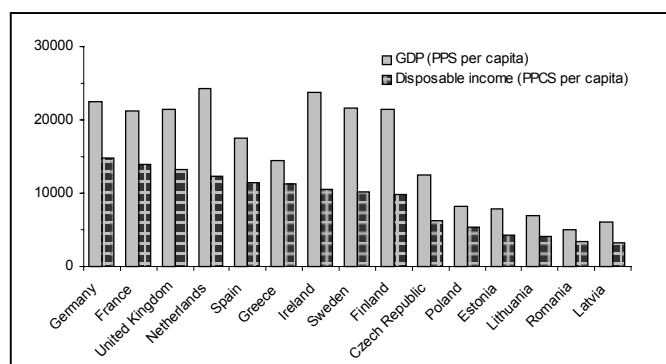


Regional disposable and primary incomes are for the first time available for part of European Union (EU) and the candidate countries (CC). The data set is not available for all the EU countries.

Even if most of the data refers up to NUTS level 2 (see annex), some are currently only available at NUTS level 1. Please note that those figures are still provisional and could be subject to revision.

## Not all GDP created in a region benefits people living in this region

Differences between GDP and disposable income arose from depreciation, transfer of money to people living abroad and taxes redistributed by governmental bodies.



Graph 1: The relation between GDP and disposable income in 1999

This graph confirms that the countries with the highest disposable income per capita were not necessarily the same in terms of GDP.

Germany, France, the United Kingdom and Netherlands had on average the highest disposable income in purchasing power standard based on final consumption

by private households (PPCS). In the annex a table is providing a regional disposable income ranking.

At national level, the disposable income is about half the GDP in Ireland, Finland, Sweden, Netherlands, the Czech Republic, Estonia and Latvia. All their regions had a disposable income/GDP rate below 70%.

The disposable income/GDP rate of Greek, German and British regions varied more widely than in the other countries. Dytiki Makedonia had a disposable income in PPCS per capita slightly higher than the GDP in Purchasing Power Standard (PPS). The rate was of 106%. The other Greek regions lay between 58% and 90%. Hamburg's rate was 41% and the other German regions were greater than 54%. Inner London disposable income represented only 32% of the GDP and the other British regions ranged between 53% and 85%. The disposable income/GDP rate for all Spanish regions was relatively uniform (58%-75%). A similar comment applied to French regions (64%-80%), excluding Île de France (51%). The situation in Inner London, Hamburg and Île de France may be mainly explained by the flow of commuting workers from surrounding regions to the city.

## GDP yields a different picture than disposable income

The nine EU countries whose data are available for 1999 represented 138 regions. The thirty last EU regions in terms of per capita GDP in PPS will be compared to the thirty last regions in terms of disposable income in PPCS per capita.

In this context, the 30 last EU regions in terms of disposable income comprised the 18 regions that qualify under both criteria:

- Greece: Anatoliki Makedonia, Thraki, Kentriki Makedonia, Thessalia, Ipeiros, Dytiki Ellada and Peloponnisos;
- Spain: Galicia, Principado de Asturias, Castilla-la Mancha, Extremadura, Andalucía, Región de

Murcia and Ceuta y Melilla;

- France: Guadeloupe, Martinique, Guyane and Réunion;
- Finland: Itä-Suomi;

together with the following additional 12 regions:

- Greece: Sterea Ellada;
- Ireland: Border, Midlands and Western;
- Sweden: 7 regions - all Swedish regions except Stockholm;
- Finland: Väli-Suomi, Pohjois-Suomi and Etelä-Suomi.

The 12 regions in the lowest category for GDP but not for disposable income were as follows:

- Greece: Dytiki Makedonia, Ionia Nisia, Voreio Aigaio and Kriti;
- Germany: Brandenburg, Mecklenburg-Vorpommern, Sachsen, Sachsen-Anhalt and Thüringen;
- United-Kingdom: Merseyside, Cornwall and Isles of Scilly and West Wales and The Valleys.

Sachsen-Anhalt, Vorei Aigaio, Cornwall and Isles of Scilly and West Wales and The Valleys are also among

the thirty last regions in terms of primary income. In other words, the redistribution by governments prevented them from being among the thirty regions having the smallest disposable income, despite the fact they were among the thirty last regions in terms of GDP.

All the regions of the six candidate countries studied (the Czech Republic, Estonia, Latvia, Lithuania, Poland and Romania) had a disposable income per capita less than almost all the thirty last EU regions. A similar observation can be made with regard to GDP per capita.

### The effect of redistribution by governments

In each country (with the exception of Greece, Germany and the Netherlands), the regions with the highest decrease of the primary income due to redistribution include the capitals.

The regions most adversely affected by the redistribution were 10 of the 12 Dutch regions, 4 of the 8 Swedish regions, both Irish regions, Uusimaa in Finland, Île de France and Inner London. They all had a disposable income representing less than 80% of their respective primary income.

We could expect that the leading regions in terms of GDP per capita would also be the ones most affected by the redistribution process. This is however not a general rule. A region like Bremen, 5<sup>th</sup> in terms of GDP per capita, had a disposable income/GDP rate close to the 166-region average.

Among the 166 regions, 27 had a disposable income greater than or equal to the primary income. United Kingdom, Germany and Greece accounted for the 13 EU regions in this group, Poland, Romania and Lithuania the 14 others.

Disposable income represented 97% or more of the primary income for the five NUTS level 1 regions of former East Germany, while it ranged between 80% and 90% for the eleven other regions. Whereas the percentage of the primary income remaining after the redistribution was 85% for Mazowieckie and 87% for the Czech Republic, it was greater than 95% for the other CC regions under consideration.

## ➤ ESSENTIAL INFORMATION – METHODOLOGICAL NOTES

1. Short definition - The disposable income of households is the available income after a redistribution process by governments. In other words, the disposable income is the primary income minus the difference between some social benefits and social contributions.
2. The regional breakdown is according to the Eurostat classification NUTS (Nomenclature of territorial units for statistics) and can be found at [http://europa.eu.int/comm/eurostat/ramon/nuts/splash\\_regions.html](http://europa.eu.int/comm/eurostat/ramon/nuts/splash_regions.html).
3. Units used - Disposable and primary incomes are expressed in purchasing power standards based on final consumption by private households (PPCS). By contrast, GDP is expressed in Purchasing Power Standards (PPS). Accordingly, these figures take into account the living cost. Data are expressed per inhabitant. Please note that those figures are still provisional, based on deliveries up to end of May 2002 and could be subject to revision.
4. This study concerns 1999 data for fifteen countries. Nine were from the European Union (EU) and six were from candidate countries. Germany and Czech Republic could not provide data at NUTS level 2 regional breakdown level. Accordingly, data referring to these two countries concerns the upper breakdown level (NUTS level 1). Extra-regio territories are not included in the analysis of household accounts variables. These countries had altogether 166 regions (NUTS level 1 and NUTS level 2 regional breakdown): 138 among EU members and 28 among CC. They totalled 364 million inhabitants: 285 out of the EUs total of 377 and 79 million from candidate countries.
5. Estimations - Data for Greece and the Netherlands were provided up to 1998. As national primary and disposable incomes were available for 1998 and 1999, the national growth rate was applied to the regions. French data on household accounts were available up to 1996. Primary and disposable incomes in PPCS were estimated for 1999 using the growth rate of regional GDP values. Data for Ireland were available up to 1998 and Romanian data was only provided for 1998. The same method was used for both these countries.
6. United Kingdom primary and disposable regional incomes were expressed in gross terms. At the national level, the gross disposable income was 4.5% greater than the net disposable income. Thus, an estimation was performed for the regional level. For France, Spain and Poland, incomes were also expressed in gross terms but no estimation has been performed. Thus, primary and disposable income may be slightly overestimated.
