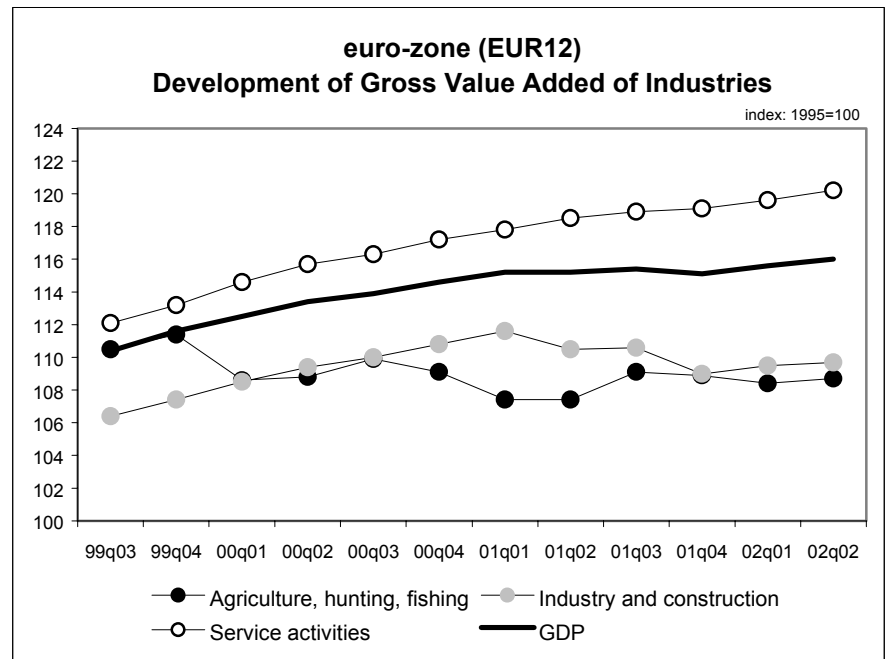

Second Quarter 2002

Output Side

Eurostat estimates ⁽¹⁾ concerning the second quarter 2002 show that the growth of Gross domestic product (GDP) remained stable at + 0.4 % both in the euro-zone ⁽²⁾ and in the European Union (EU15), compared to the previous quarter.

The progression of total Gross value added (GVA) during the second quarter 2002 remained stable at + 0.4 % in the euro-zone and accelerated in the EU15, reaching + 0.5 % (+ 0.3 % during the previous quarter). Compared to the second quarter 2001, GVA expansion accelerated, passing to + 0.8 % in the euro-zone and to + 0.9 % in the EU15 (+ 0.5 % for both zones during the previous quarter).

Concerning the contribution to the GDP growth, the *Industry* branch, the *Financial activities and business services* branch, the *Other service activities* branch as well as the *Trade, transport and communications* branch have all contributed positively to the growth of the euro-zone and the EU15 (+ 0.1 of the GDP variation for both areas for the four branches mentioned). On the other hand, the *Construction* branch did not have practically any outcome on the GDP growth (+ 0.0 of the GDP variation for both areas), just as the *Agriculture, hunting and fishing* branch.

⁽¹⁾ Methodological note: data for the euro-zone and EU15 are calculated in a coherent statistical framework, using as indicators the data of all the Member States compiling quarterly accounts. Aggregations for the euro-zone and EU15 were carried out using the seasonally adjusted data of the Member States. These data are also corrected for working days for Belgium, Germany, Spain, France, the Netherlands, Sweden and the United Kingdom.

⁽²⁾ The euro-zone consists of Belgium, Germany, Greece (starting from 2001), Spain, France, Ireland, Italy, Luxembourg, the Netherlands, Austria, Portugal and Finland. Euro-zone data cover eleven Member States till end 2000; with Greece's entry into the euro-zone from the beginning of 2001 onwards, they cover twelve Member States. For the graphs on page 1 and 6 only, the aggregate EUR12 is shown for the whole period covered.

DEVELOPMENT OF GDP AND GVA BY INDUSTRY

The euro-zone and the EU15

Eurostat estimates for the second quarter 2002 show that the growth of Gross domestic product (GDP) remained stable at + 0.4 % both in the euro-zone and in the European Union (EU15), compared to the previous quarter.

The progression of total Gross value added (GVA) during the second quarter 2002 remained stable at + 0.4 % in the euro-zone and accelerated in the EU15, reaching + 0.5 % (+ 0.3 % during the previous quarter). Compared to the second quarter 2001, GVA expansion accelerated to reach + 0.8 % in the euro-zone and + 0.9 % in the EU15 (+ 0.5 % for both during the preceding quarter).

GVA growth in **Financial services and business activities** recorded acceleration, reaching + 0.5 % in the euro-zone and + 0.6 % in the EU15 (+ 0.2 % for both areas during the previous quarter). This branch recorded the highest growth rates among all branches during the second quarter 2002.

The GVA growth rate concerning the **Other service activities** branch, compared to the previous quarter, remained stable at + 0.5 % in the euro-zone as well as in the EU15.

The GVA development of the **Trade, transport and communications** branch accelerated, reaching + 0.5 % both in the euro-zone and in the EU15 (+ 0.4 % for both during the previous quarter).

The GVA of the **Industry** branch saw slower growth than before, increasing by + 0.3 % in the euro-zone and by + 0.4 % in the EU15 (+ 0.8 % and + 0.5 %, respectively, in the previous quarter).

GVA in the **Construction** branch in the second quarter 2002 developed slightly less negative than in the first quarter in the euro-zone, passing from - 0.7 % to - 0.6 %. The decline remained unchanged at - 0.2 % in the EU15.

Value added of the **Agriculture** branch showed a recovery, with a + 0.3 % and + 0.1 % increase in the euro-zone and in the EU15, respectively (- 0.5 % and - 0.4 %, respectively, during the previous quarter).

The Member States of the European Union

During the second quarter 2002, the growth of total Gross value added recorded acceleration in Denmark (+ 1.0 %), in Spain (+ 1.0 %), in Portugal (+ 0.9 %) and in the United Kingdom (+ 0.5 %), along with a recovery in the Netherlands (+ 0.1 %) and in Finland (+ 2.2 %). The growth of total Gross value added

remained stable at + 0.5 % in France and in Austria. On the other hand, it slowed in Belgium (+ 0.2 %) and in Germany (+ 0.3 %), stagnating in Italy (+ 0.0 %).

With regard to the production branches, **Agriculture, hunting and fishing** presented the maximum growth in Belgium (+ 1.5 %), as well as the most significant decline in Portugal (- 3.1 %). For **Industry, including energy**, the best result was that of Finland, with a + 4.6 % resumption, whereas Italy recorded the strongest reduction with - 1.4 %. The highest growth of the **Construction** branch was observed in Sweden, with a recovery reaching + 2.0 %; the sharpest fall was noticed in Germany, with - 2.2 %. The **Trade, transport and communications** branch recorded its best performance in Finland, with an acceleration reaching + 1.7 %, and the only fall in the Netherlands (- 0.1 %). The **Financial activities and business services** branch presented the highest growth in Portugal, with a recovery reaching + 3.1 %, and the least one in Austria, with a - 1.2 % fall. Finally, the best results for the **Other services** branch were observed in Spain and in Finland (+ 0.9 % for both), with Italy presenting the only decline (- 0.1 %).
