

External Trade of Western Balkan Countries

Strong growth in Western Balkan countries' (WBCs) trade with the European Union

Highlights

The following pages outline the situation of the Western Balkan countries (WBCs) with regard to international trade in goods. The Western Balkan countries are Croatia (HR), Bosnia and Herzegovina (BA), Serbia and Montenegro (CS)*, the former Yugoslav Republic of Macedonia (MK)* and Albania (AL).

Main features:

- External trade of the WBCs has strongly increased over recent years (60% growth over the period 1999 to 2003).
- The growth rate was higher with the European Union (EU-25) than with the rest of the world.
- The European Union (EU-25) is the number one trading partner, accounting for more than 84% of WBCs' trade.
- Among the WBCs, Croatia (HR) is by far the major partner of the EU-25, accounting for 50% of the WBCs' trade with the European Union (EU-25).
- Trade between Croatia (HR) and Bosnia and Herzegovina (BA), and between Serbia and Montenegro (CS)* and the former Yugoslav Republic of Macedonia (MK)* accounts for nearly 75% of the total trade between the WBCs.

A strong growth in trade in general

Between 1999 and 2003, world trade with the WBCs increased by 60% (figure 1). Growth was most pronounced over the period 1999 to 2001 (+43%). These exceptional growth rates stem from an economic situation in 1999 showing very limited volumes of external trade. Growth was especially marked for exports to the WBCs. European Union (EU-25) exports to the WBCs increased by 63% in 2003 compared to 1999. Over the same period, trade flows for the rest of the world with these countries increased by 48%.

The EU-25 is the WBCs' biggest trading partner...

Among the world regions, the European Union (EU-25) conducts by far the most trade with the WBCs (figure 2). Indeed, in 2003 the European Union accounted for more than 84% of the WBCs' total foreign trade. In descending order, the world regions having the most trade with these countries are the Candidate Countries (CCs: Romania, Bulgaria, Turkey) with 4%, the New Independent States and Mongolia (TACIS) with 4%, the EFTA countries (Iceland, Liechtenstein, Norway, Switzerland) and the United States of America (US) accounting for 2% each.

Both for imports and exports, the EU-25 is the world region conducting the most trade with the WBCs. The European Union is the biggest supplier to and the biggest customer of the WBCs.

... and among the WBCs, Croatia is the first partner of the EU-25





Figure 3: EU-25 trade with WBCs broken down by WBC - Total value of trade - 2003

The main EU-25 trading partner among the WBCs is Croatia which, in 2003, accounted for more than 50% of the total trade of the EU-25 with the WBCs, followed by Serbia and Montenegro (CS)* with 23 % (figure 3). Among the WBCs, Albania accounts for the smallest share, making up 6% of trade between the EU-25 and WBCs.

Figure 2: Breakdown by world's region of trade with WBCs – Total value of trade - 2003

Distribution and structure of world trade with the WBCs

Products imported by the partners of the WBCs ...

The breakdown (by section of the Harmonised System) of world imports coming from the WBCs (table 1) shows a trade structure focused on manufactured goods such as textiles (section XI), base metals and articles of base metal (XV) and machinery and electrical equipment (XVI), which account respectively for 16%, 15% and 13% of the total products imported by the world from the WBCs. They are the most important types of commodities, whereas high added valued manufactured products and the agricultural products and foodstuffs represent smaller shares. For all the categories of products, except live animals and animal products (I), pearls, precious stones and metals (XIV) and arms and ammunition (XIX), trade with the European Union (EU-

25) represents more than 60% of all imports coming from the WBCs.

... differ from those exported by these partners to the WBCs

On the whole, exports to the WBCs (table 2) by far exceed imports. The products most exported to the WBCs are machinery and electrical equipment (XVI), accounting for 22% of total exports, vehicles (XVII), 11%, the products of the chemical and allied industries (VI), 10%, and the base metals and articles of base metal (XV), 9%. For all commodities, except mineral products (V), more than 70% of exports to the WBCs come from the EU-25.

Structure and evolution of EU-25 trade with the WBCs

Fluctuating growth of imports from the WBCs ...

The commodities most imported by the EU-25 from the WBCs are textiles (section XI), 18% of imports, base metals and articles of base metals (XV), 16%, and machinery and electrical equipment (XVI), 12%.

With regard to the total trade in goods, the remarkable growth of imports to the EU-25 coming from the WBCs slowed down as the years passed (table 3). With the exception of machinery and electrical equipment (XVI), the evolution for most of the categories of products fluctuated. Even imports to the EU-25 of products of the textile sector (XI) do not seem to have taken off as, after two years of strong growth, decreases were recorded during the following two years.

... but more constant growth for exports

Machinery and electrical equipment products (XVI),

vehicles (XVII), and base metal and articles of base metal (XV) alone cover 45% of total exports from the EU-25 to the WBCs. Moreover, they recorded among the strongest growth rates over the last five years (especially at the beginning of the period). Comparing 2001 to 2000, base metal and articles of base metal (XV) and machinery and electrical equipment (XVI) increased by 22% and 32% respectively (table 3). At a slightly lower level, exports of chemical and allied products (VI), foodstuffs (IV) and plastic and rubber (VII) progressed well over the same period.

The gradual slow-down in the growth rates for imports over the period 1999-2003 is also true for exports from the EU-25 to the WBCs. The high levels of growth at the beginning of the period did not continue in 2003. However, the data for the year 2003 discussed in this text are not all final and are likely to be revised.

Similar trade structure of each country with the EU-25 ...

Tables 4 and 5 confirm that among the WBCs, Croatia and Serbia and Montenegro (CS)* are the largest partners of the European Union (EU-25) for both exports and imports. It also appears that the trade structure by product between the EU-25 and each WBC is relatively similar. Indeed, we note that textile products (section XI) and base metal and articles of base metal

(XV) account for more than one third of imports to the EU-25 coming from each WBC. For certain countries, like the former Yugoslav Republic of Macedonia (MK)*, these products cover almost 70% of imports to the EU-25. Machinery and electrical equipment (XVI) are largely exported by the EU-25 to each of these countries, more or less covering 20% of exports of the EU-25 to each of them

Structure of the trade between the WBCs

... but particular trade among the WBCs

It is interesting to establish a matrix of exports/imports between the WBCs. Taking into account the availability of the data, this matrix covers data for the year 2002 and has had to be partially reconstituted on the basis of mirror statistics. It has the advantage of identifying flows between partners and thus makes it possible to pinpoint special trading relations.

As can be seen in table 6, Croatia conducted the greatest part of its trade within the area with Bosnia and Herzegovina and the former Yugoslav Republic of Macedonia (MK)* is a favoured partner for Serbia and Montenegro (CS)*.

From the point of view of the categories of products traded between themselves, table 7 shows that the WBCs trade especially foodstuffs (IV) and minerals, including fuels (V), and chemical products (VI). There is also trade in base metal and articles of base metal (XV) and machinery and electrical equipment (XVI).

> ESSENTIAL INFORMATION - METHODOLOGICAL NOTES

Data sources:

The contents of this "Statistics in Focus" are based on data available in Eurostat's Comext database. Foreign trade data for EU-25, WBCs, CCs, EFTA and TACIS countries have been extracted from Comext's specific domains (Source: Eurostat), whilst the world total foreign trade value and the US foreign trade data have been extracted from the Comtrade domain in Comext (Source: UN/Comtrade). The data for the year 2003 discussed in this "Statistics in Focus" were extracted in the course of September 2004 and may be subject to revision.

Scope, partner country and valuation:

- In the methodology applied to EU external trade of goods statistics (trade between EU Member states and non-member countries), statistics do not record exchanges involving goods in transit, placed in customs warehouses or given temporary admission (for trade fairs, exhibitions, tests...). This is known as "special trade".
