ACCESSION NEGOTIATIONS WITH GREECE

Sixth Report

on the examination of Community secondary legislation

(Acts relating to the institutional, budgetary and staff regulations fields)

(Commission Communication to the Council)

COM(77) 438 final.

I. In continuation of the systematic examination of Community secondary legislation undertaken with the Greek Delegation in accordance with the brief received from the Council, the Commission has examined all the general acts of the institutions of the Communities in the institutional, budgetary and staff regulations fields which were in force on 30 March 1977.

This examination did not, however, cover those acts which, although possibly having institutional or budgetary relevance, have been or will be examined in the context of other specific fields, for example the texts relating to the committees set up in the various areas of Community activity.

Subject to the remarks below, the results of the examination are contained in the two annexes to this report:

Annex I lists the acts not requiring any technical adaptation;

Annex II gives the only act in respect of which technical adaptations are necessary and the exact wording of those adaptations.

II. The examination of the acts relating to the three complementary fields in question calls for the following additional remarks:

A. In the institutional field

1. The Council Decision of 1 January 1973 altering the number of Members of the Commission (OJ L 2, 1.1.1973, p. 28) and the Council Decision of 1 January 1973 increasing the number of Advocates-General (OJ L 2, 1.1.1973, p. 29) were left out of the examination of this field, carried out with the Greek Delegation.

The assessment of whether the number of Members of the Commission and Advocates-General of the Court of Justice should be increased is a matter that falls outside the scope of "technical" adaptations and one that will have to be dealt with in the substantive negotiations, along with all the other institutional questions raised by Greece's accession to the Communities.

The same applies to the Council Decision (76/787/ECSC, EEC, Euratom) of 20 September 1976 relating to the Act concerning the election of the representatives of the Assembly by direct universal suffrage (OJ L 278, 8.10.1976, p. 1). Here too, the adaptations made necessary by Greece's accession are a matter for the substantive negotiations, since they are of an essentially political nature.

2. The acts relating to this field include the rules of procedure of the institutions of the Communities, namely:

- (i) the rules of procedure of the European Parliament (July 1976 - not published in the Official Journal);
- (ii) the provisional rules of procedure of the Council (not published in the Official Journal);
- (iii) the provisional rules of procedure of the Commission: Decision 67/426/EEC - 67/24/Euratom of 6 July 1969 (OJ No 147, 11.7.1967, p. 1), as amended and supplemented by Decisions 70/328/ECSC, EEC, Euratom of 2 July 1970 (OJ L 145, 3.7.1970, p. 28), 73/1/ECSC, EEC, Euratom and 73/2/ECSC, EEC, Euratom of 6 January 1973 (OJ L 7, 6.1.1973, pp. 1 and 2), and 75/46/Euratom, ECSC, EEC of 23 July 1975 (OJ L 199, 30.7.1975, p. 43)

and the rules of procedure of the two Committees established by the ECSC Treaty and the EEC and EAEC Treaties respectively, namely:

- (iv) the internal regulations of the Consultative Committee of the ECSC (1974) (OJ C 32, 22.3.1974, p. 1);
- (v) the Revised Rules of Procedure (74/428/EEC, Euratom) of the Economic and Social Committee (OJ L 228, 19.8.1974, p. 1).

These various sets of rules of procedure will doubtless have to be adapted in line with the changes made in the composition of the relevant institutions and committees following the enlargement of the Communities.

It is clear, however, that any such adaptations will have to be made by each of the institutions or committees in question once they are reconstituted following Greece's accession - as was the case with the previous enlargement operation. To that end, the act of accession for Greece could contain provisions similar to those of Articles 139(2) (for the Assembly), 140(2) (for the Council), 141(2) (for the Commission) and 147 (for the Committees) of the Act of Accession of 22 January 1972.

Consequently these acts are not mentioned in either of the annexes to this report.

3. The examination of the acts relating to this field also covered the Rules of Procedure of the Court of Justice of 14 December 1974 (OJ L 350, 28.12.1974, p. 1).

It is clear that Greece's accession will necessitate certain adaptations to these Rules of Procedure, particularly as regards Article 29 (the language of a case), Annex II (time limits on account of distance) and the lists referred to in Articles 2, 4 and 6 of the Supplementary Rules, which appear in Annexes I, II and III thereto. However, as with the previous enlargement operation, it will be for the Court of Justice itself (with the unanimous approval of the Council) to incorporate in its Rules of Procedure, after Greece's accession, the adaptations made necessary by that accession. To that end, a provision similar to Article 142(4) of the Act of Accession of 22 January 1972 will have to be included in the act of accession for Greece.

The act in question is not therefore mentioned in either of the annexes to this report.

4. The acts referred to in Annex I include Council Regulation (Euratom, ECSC, EEC) No 857/72 of 24 April 1972 providing for special editions of the Official Journal of the European Communities (OJ L 101, 28.4.1972, p. 1).

This Regulation, the object of which was to ensure the publication in the languages of the new Member States of all the acts that were to be authentic from the date of accession under the same conditions as the texts drawn up in the four original Community languages, does not itself require any technical adaptation. It should be noted, however, that Greece's accession will make it necessary for the Council to adopt a similar act for the production of a new special edition of the Official Journal in which all the acts of the Communities in force on the date of Greece's accession would be published in Greek.

5. The acts listed in Annex I (which do not require technical adaptation) include the Joint Declaration of the European Parliament, the Council and the Commission of 4 March 1975 on acts of general application which have appreciable financial implications.

Although this is not strictly speaking an act of Community secondary legislation and has no binding legal force, it was felt that the Joint Declaration should be brought to the Greek Delegation's attention in the context of Community legislation to date. Naturally, there is no need to adapt the Declaration to take account of Greece's accession.

B. In the budgetary field

1. The Council Decision of 21 April 1970 (70/243/ECSC,EEC, Euratom) on the replacement of financial contributions from Member States by the Communities' own resources (OJ L 94, 28.4.1970, p. 19) is not mentioned in the annexes to this report.

This Decision is equivalent in scope to the provisions of the Treaties. Any adaptations that might be made thereto and the transitional arrangements that might be made by virtue of Greece's accession are linked to the substantive problems to be resolved in the accession negotiations.

2. The various Council Decisions relating to the Audit Board¹ were not included in the examination of the acts relating to the field in question. It was decided that there was little point in examining those Decisions since they are due to lapse within the very near future as a result of the entry into force on 1 June 1977 of the Treaty of 22 July 1975 amending Certain Financial Provisions of the Treaties establishing the European Communities and of the Treaty establishing a Single Council and a Single Commission of the European Communities. The object of this Treaty is to establish a Court of Auditors and it stipulates that the powers of the Audit Board will lapse on submission of the report for the 1976 financial year.

Moreover, the Treaty of 22 July 1975 was also left out of this work since it does not constitute an act of Community secondary legislation.

3. The examination of the acts relating to this field did, however, cover the financial provisions of the Convention between the Member States of 19 April 1972 setting up a European University Institute (OJ C 29, 9.2.1976, p. 1).

On the basis of that examination, the Commission wishes to make the following remarks:

- (i) Greece's accession to the Communities will doubtless mean its accession to the above Convention, as was the case with the three new Member States.
- (ii) Greece's accession to the said Convention will necessitate modification of the scale of the Member States' financial contributions as laid down in Article 19(1) (subject to the establishment of a different financing basis as from 1978 in accordance with Article 19(2)).

C. In the staff regulations field

The acts relating to this field listed in Annex I (acts not requiring technical adaptations) include:

The whole of the Annex to this Regulation will have to be amended to include the equivalent version of each entry in Greek.

However, it is felt that this amendment, which will completely change the presentation of the whole Annex, can best be carried out - as was done when the three new Member States acceded (the object of the above regulation being to amend the Annex in question) - by a new amending regulation to be

adopted by the Council of the enlarged Community after Greece's accession, rather than by means of technical adaptations included in the act of accession, which would make that act excessively voluminous.

A weighting applicable to Greece will doubtless have to be added to Article 5(2), which fixes the weightings applicable at 1 January 1977. However, it seems appropriate to make this addition not through a technical adaptation of the text in question but in the context of the first periodical revision of all the weightings following accession.

III. The Greek Delegation has stated that it does not consider it necessary for there to be any deferment, within the transitional period, of the date of application or of the time limit for the putting into effect of any of the acts mentioned in the annexes to this report.
