1.0 General Introduction

This working document to the Report from the Commission to the Council and the European Parliament contains information on the generation, treatment and transboundary shipment of hazardous waste and other waste in the Member States of the European Union (EU), 2013-2015.

The report is comprised of five sections and contains both quantitative and qualitative information on waste generation and treatment:

- **Section A:** Provides a quantitative outline of Member States' waste transactions. This information was provided by Member States in their responses to the Basel Convention Implementation Questionnaire;
- **Section B:** Summarises Member States' provisions regarding waste management in line with the Basel Convention. This information was provided by Member States in their responses to the Basel Convention Implementation Questionnaire;
- **Section C:** Provides an up-to-date list of the Competent Authorities to the Basel Convention. This information was provided by Member States in their responses to the Basel Convention Implementation Questionnaire;
- **Section D:** Provides a list of the Y-codes for waste according to the Basel Convention; and
- **Section E:** Summarises Member States' provisions regarding waste management in line with the Waste Shipment Regulation. This information was provided by Member States in their responses to the Waste Shipment Regulation Implementation Questionnaire.

A summary of the state of reporting for the Basel Convention Implementation Questionnaire in regards to Article 51(1) of the Waste Shipment Regulation (WSR), and the WSR Implementation Questionnaire in regards to Article 51(2) of the WSR for the years 2013-2015 is shown in Table 1-1.

For practical reasons, the report does not differentiate between direct quotes from the Member States' replies and other re-phrased or shortened passages. The original replies from the Member States constitute the only "authentic" document submitted by the Member States.

It should be noted that the Basel Convention uses the terms "import" and "export" for every shipment into and out of a country that is Party to the Convention. Under EU law these terms apply only to shipments into and out of the EU as a whole. However, for the sake of readability, in the Implementation Report accompanying this working document the terms appear in inverted commas, and are used occasionally for waste shipments in general (i.e. as applied in the Basel Convention). In this document both terms appear in the sense in which they are used in the Basel Convention.

Figure 2.1: Total Generation of All Notified Waste Per Capita in EU Member States, 2013-2015, in kg per capita




Figure 2.3: Export of Hazardous Waste, 2013-2015, in kg per capita



Figure 2.4: Export of Hazardous Waste out of Each Member State in Relation to Generation in 2015, in % distribution



Figure 2.5: Export of All Notified Waste, 2013-2015, in kg per capita



Figure 2.6: Distribution of All Reported Export Waste by Waste Type in 2015, in % distribution



Figure 2.7: Distribution of All Reported Export Waste by Waste Type in 2014, in % distribution



Figure 2.8: Distribution of All Reported Export Waste by Waste Type in 2013, in % distribution



Figure 2.9: Total EU-28 Distribution of All Reported Export of Waste, 2001-2015, in million tonnes



Figure 2.10: EU-28 Treatment of Hazardous Waste, 2001-2015, in million tonnes




Figure 2.11: Treatment of Hazardous Waste in 2015, in % distribution





Figure 2.12: Treatment of Hazardous Waste in 2014, in % distribution





Figure 2.14: Destination of All Notified Waste, 2001-2015, in 1,000 tonnes




Figure 2.16: Import of Hazardous Waste, 2001-2015, in kg per capita



Figure 2.17: Import of Hazardous and All Other Notified Waste into Member States, 2001-2015, in kg per capita



Figure 2.18: Distribution of Imported Waste by Waste Type in 2015, in % distribution



Figure 2.19: Distribution of Imported Waste by Waste Type in 2014, in % distribution



Figure 2.20: Distribution of Imported Waste by Waste Type in 2013, in % distribution



Figure 2.21: Treatment of Hazardous Waste Shipped into Member States, 2001-2015, in million tonnes




Figure 2.22: Treatment of Hazardous Waste Shipped into Member States in 2015, in % distribution





Figure 2.23: Treatment of Hazardous Waste Shipped into Member States in 2014, in % distribution





Figure 2.25: All Hazardous Waste and Other Notified Wastes Shipped into EU-groups, 2001-2015, in 1,000 tonnes




Figure 2.27: Top Treatment of all Notified Waste Exported by EU Member States, 2013-2015, in 1,000 tonnes



¹ The Netherlands has provided information that in their Basel reports they have issued "other hazardous waste" for all waste which could not be classified otherwise, i.e. by using one of the Basel Convention's Y-code (Y1 to Y47). However, hazardous waste (as defined by the European Waste List) has not been transported out of the EU to non-OECD countries. This illustrates a classification problem encountered by many Member States. Within the EU the waste is predominately classified according to the European Waste List. As there is no unique relation between the EWL-codes and the Basel-codes, Member States have to find solutions for waste that cannot be classified by one of the Y-codes in the Basel Convention.

Figure 2.28: Export of Hazardous Waste out of the EU (all treatments), 2001-2015, in tonnes




