

# EEA Aquaculture Production in 1997

## Introduction

Aquaculture production by EEA countries in 1997 was 1.55 million tonnes (see Table 4), 12% of the total fisheries production and an increase of 42% over the production in 1990. 1.19 million tonnes, 76% of the total, was produced in the 15 EU Member States.

The value of the aquaculture production in 1997 was 3 131 million EUR, a 39% increase in the value of the 1990 production. The 15 EU Member States' production had a value of 2 198 million EUR, 70% of the EEA total.

In 1997 the EEA aquaculture production was 4.3% of the world total by weight. This was a decrease from the 6.5% of the 16.8 million tonnes of the world production in 1990 but can be explained by the great increase in the reported production by China from 8.0 million tonnes in 1990 to 24.0 million tonnes in 1997.

## Production by species groups.

In 1997, 824 thousand tonnes or 53% of the EEA aquaculture production was of fish species, with virtually all of the rest being molluscs (see Table 2). The fish production was an increase of 83% over the 1990 production. In comparison, the increase in mollusc production, at 14%, was relatively minor.

The value of the EEA fish culture production in 1997 at 2 415 million EUR was an increase of 52% over that for 1990. In the same period the value of the mollusc production increased by only 11%. This disparity between the increase in the quantity of fish produced and the lesser increase in the value of the production is demonstrated in a decrease in the unit value of the fish produced of 17% in the period 1990-97 (see Table 1). In comparison, the unit value of mollusc production has remained relatively stable, decreasing by only 3%.

## Major species in EEA aquaculture.

Two species, the Atlantic salmon (*Salmo salar*) and the Rainbow trout (*Oncorhynchus mykiss*) accounted for 87% by volume and 78% by value of the fish reared in the EEA in 1997 (see Table 2). This was largely due to the 331 thousand tonnes of Atlantic salmon produced in Norway, 40% by volume of the total EEA reared fish production. These same two species also made the largest contribution to the EU reared fish production (77% by volume and 65% by value) though their relative importance was reversed.

The European eel (*Anguilla anguilla*) had the highest unit value (8 802 EUR/tonne) in 1997 followed by the European seabass (*Dicentrarchus labrax*) and the Gilthead seabream (*Sparus aurata*) at 6 772 and 5 943 EUR/tonne respectively.

The major mollusc species reared in the EU (and, since production of molluscs in Iceland and Norway is negligible, in the EEA) were the Pacific cupped oyster (*Crassostrea gigas*) and the Blue mussel (*Mytilus edulis*).

A study of the changes in production over the period 1990-97 (see Table 3) reveals that those fish species for which the largest increases in production were recorded (the Atlantic salmon, the European seabass and Gilthead seabream) have seen a large decrease in the unit value of the product. Conversely, those more traditional farmed species such as the Common carp, the Rainbow trout and the European eel, where the production has not changed to the same extent have demonstrated a smaller, albeit negative, change in the unit value.

Changes in mollusc production in recent years have been generally more the result of biological and environmental factors than they have of developments in the industry and thus changes in the volume, value and unit value have been relatively modest.
